

CO-RESPONSIBILITY EDUCATIONAL AGREEMENT
(according to Art. 3 D.P.R. 235/2007 with additions relating to the health emergency Covid-19)

All the components of the school commit to collaborate on the reinforcement of the human and cultural growth of the students. Students are active participants in the didactic action which tends to add value and supports the motivation to study, contributing to the formation of critical and responsible attitudes. This is the articulation of the commitments, the respect of which the Academic Board intends to urge in all school components:

THE TEACHERS

- a) commit to involve the students in knowing the general and specific objectives of their discipline;
- b) plan their own didactic activity according to what has been agreed upon in the College, in the Class Councils, in meetings with colleagues of the same subject;
- c) explicate the means of verification and criteria for evaluation, involving the student personally;
- d) they also undertake to:
 - inform, share, monitor the general behaviours required to tackle the spread of COVID-19 epidemic, based on the Technical Document of the CTS of May 28th, 2020 and the Ministerial Decree of June 26th, 2020 and subsequent amendments;
 - ensure that students comply with the epidemiological, organizational and sanitary risk containment measures envisaged by the school in ALL didactic activities.

THE STUDENTS

- a) commit to regularly attend the lessons and other activities planned by the school;
- b) dedicate the necessary time to study;
- c) respect the standards of conduct listed in the Institute regulations and in particular ones of a hospitality training institute, namely:
 - responsible behaviour to be held both at school and during company visits, educational trips, internships and other didactic activities;
 - language marked by the utmost correctness, never vulgar or disrespectful towards anyone;
 - clothing, hygiene and hair based on the rules adopted in the 1st category hotel and catering establishments;
 - use of the uniform in laboratories, in particular during company visits, internships, in operational practice, etc.
- d) participate in an active way to the life of the school also through their class representatives;
- e) commit to paying particular attention to the execution of every school activity that is carried out in compliance with the risk containment measures and the use of preventive and protective equipment (i.e. social distancing, use of mask, etc.);
- f) strictly observe the preconditions for the attendance at school (respiratory symptoms or temperature above 37,5°C, absence of quarantine states and contact with positive individuals, etc.)
- g) respect the school entrance hours.

THE PARENTS

- a) commit to continuously monitor the academic progress of their child also through weekly and periodical meetings with the teachers;
- b) consult the electronic logbook and the institute's website to view teacher notes, evaluations and notices;
- c) report to the school all potential problems regarding their child or the class, in order to adopt adequate measures;
- d) express opinions or make proposals, directly or through their representation and the Parents Committee, for the improvement of the school;
- e) to counteract the COVID-19 epidemic they commit to:
 - check that their own children are equipped with personal protective devices and wear them if required (mask);
 - check on their state of health and not send them to school whenever the aforementioned preconditions for the access to the school are not met;
 - cooperate so that the children respect the entrance hours and notify in the event of any justified delays.

Respect for school entrance times is considered normal and correct behaviour in general but, even more so, in the organisation of the safe restart of the next school year.
